Who we are:

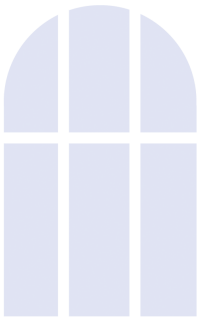

What information we collect about you:

We collect information about you when you enquire about our services or make an appointment with us for treatment. We will retain details and clinical notes relating to the care you receive within our practice and from third parties. We also collect information about you when you voluntarily complete customer surveys or provide feedback to us.

What Personal information do we need to hold?

- Your past and current medical and dental condition; personal details such as your name, age, address, telephone number and your general medical practitioner.
- We may also need to request details of your child's NHS exemption status
- Radiographs, clinical photographs and study models.
- Information about the treatment that we have provided or propose and its cost.
- Notes of conversations or incidents that might occur for which a record needs to be kept.
- Records of consent to treatment.
- Any correspondence relating to you with other health care professionals, for example in the hospital or community services.

How we will use the information we have about you:

We will use information about you to enable us to arrange appointments with the appropriate clinician and to ensure that you are receiving care appropriate to your clinical needs. Our regulators The General Dental Council require us to create and retain records of the dental treatment that is provided to patients. We are obliged by law to keep these records for ten years after the last date of treatment.

We will not disclose your personal data, including records of your treatment, unless required to do so by law, or with your explicit consent (if you have been referred for treatment with us by another medical professional, we may disclose details of your treatment to them where appropriate). Wherever possible we will discuss and disclose with you in advance. We will never pass on your information to a third party for marketing purposes.

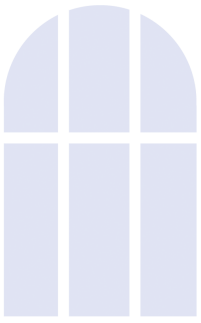
We may share your information with selected third parties including; business partners, suppliers, and sub-contractors for the performance of any contract we enter into with them or you; analytics and search engine providers that assist us in the improvement and optimisation of our website; credit reference agencies for the purpose of assessing your credit score where this is in connection of us entering into a contract with you.

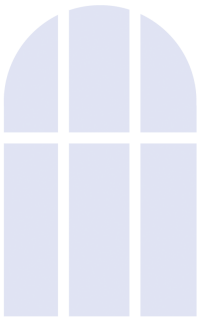
